It is declared:

- that the composition is original work of the author and unpublished;
- that the composition is not the work of a paid commission nor has it been submitted to another competition;
- that the composition has not been previously performed in a concert or public event;
- that the composition has not been transmitted by any broadcast media;
- that the proposed composition is distinct, original and developed expressly for this Jubilee 2025 competition;
- to relinquish, free of charge, in the event that the composition of this proposal is the winner, the exclusive ownership of the same and all broader and exclusive rights to the same composition to the Dicastery for Evangelization - Section for Fundamental Questions of Evangelization in the World (DEFQ) which, consequently, will acquire over the aforementioned composition all exclusive rights of economic use and enjoyment- none excluded or excepted, including any related rights - and of reproduction, recording, deposit and publication, as well as to modify, adapt, and/or adjust to professional musical standards, all - each of the aforementioned rights -without limitation of space and time, by any means of reproduction, even unknown today for its own purposes, without the author(s) being able to make any kind of claim in the future (it is to be noted that the author(s) will be explicitly named as the composer of the music);
- to therefore be aware that, in the event that the composition in this proposal is chosen, the same shall be retained in the assets of the DEFQ and that, notwithstanding the gratuitous donation and all that is stipulated in the preceding paragraph, before proceeding and as an essential condition of winning and its eventual announcement, he/she shall provide for any formalization with an appropriate and compliant public act of donation to the DEFQ, under penalty of disqualification;
- to assume all responsibility for the authorship, novelty and originality of the submitted composition and to accept, by signing and submitting the documents for participation in the respective public announcement, as stipulated in the Regulations for the creation of the composition;
- to guarantee the absolute originality and authorship of the entire proposal submitted and to have on the same every broad and exclusive right of use and enjoyment and, assuming total and exclusive responsibility, declares to guarantee

and exonerate the DEFQ and the Holy See from any claim that, in this regard, might be made against them by any third party;

- to accept without reservation or exception the contents of the aforementioned Regulation for the creation of the composition of the Hymn;
- to be aware and consent that their personal information, included in this application, will be used, also by electronic means, exclusively within the scope of the procedure for which this application is submitted;
- to accept that the information collected will be processed by the DEFQ, may be communicated to the competent administrations and/or authorities of the State of Vatican City for checks on the statements made, and will be kept for the time necessary to conclude the procedure for which this application was submitted and in any case for at least five years from the date of the opening of the competition.
